CIRCULAR LETTER PEN 07/03

The Supervision and Substitution Payment: Determination of the amount to be included in pension

- 1. Circular Letter PPT 01/03 informed authorities of post-primary schools of the arrangements in regard to paid supervision and substitution, including the conditions governing the pensionability of the supervision and substitution payment. Teachers currently in service do not have to commit to carry out the supervision and substitution duties on an ongoing basis until 1 September 2004. In determining whether the payment is pensionable, therefore, a distinction needs to be made between teachers who retire or have retired before 1 Sept 2004 and those who retire after that date.
- 2. (a) Teachers who retire or have retired before 1 September 2004.

Any payments made to a teacher by the VEC in respect of supervision and substitution, up to the agreed limit of 37 hours per year, will be regarded as pensionable payments.

(b) Teachers retiring on and from 1 September 2004.

Payments made for supervision and substitution, up to the agreed limit of 37 hours per year, will be regarded as pensionable only where the teacher has (i) made the ongoing commitment and has (ii) delivered on the commitment up to retirement.

A teacher who enters such a commitment but later ceases to meet the commitment will forfeit pensionability of the supervision/substitution payment and will not be allowed to re-enter such a commitment. A teacher who forfeits pensionability of the payment will not be entitled to a refund of superannuation contributions made in respect of the payment.

3. Calculation of the amount of the supervision/substitution payment which should be included in pension.

Provided pensionability has not been forfeited, the amount of the payment which will be included in the teacher's pensionable remuneration will be one third of the total pensionable payments received in respect of the teacher's final 3 years of pensionable service. A teacher who receives payment for carrying out the full duties over the complete period from 1 September 2001, the date of introduction of the payment, to retirement on 31 August 2004 will therefore have the full payment, as averaged over his or her last 3 years of pensionable service, reckoned in pension.
