## ETB Payroll Project - our Year to Date & 2019 Plans

### 2018 Highlights

- Contract signed with CoreHR for the provision of a payroll system in May 2018.
- Information Gathering: CoreHR Discovery workshops and Information gathering templates for system configuration completed. This could not have been done without the significant support & expertise provided by ETB staff members.
- Conference Room Pilots: completed November 2018. Subject
  Matter Experts (SMEs) from the ETBs in conjunction with ESBS
  staff attended these sessions where the new ESBS ETB Payroll
  system was demonstrated by CoreHR.
- ETB Wave Migration: click on the <u>link</u> to see our latest version of the Wave Migration Strategy
- Payroll and T&S Policies: click on the <u>link</u> to see our latest version of the ESBS ETB Payroll Policies.
- Process Mapping: click on the <u>link</u> to see the Level 3 To-Be process maps published in October 2018 along with the revised ESBS/ETB Activity Split <u>here</u>. The Level 4 maps have also recently been completed and were circulated on 14<sup>h</sup> Dec for ETBs to review.
- Data Mapping & Data Migration: the ESBS team are working in close collaboration with DDLETB & CMETB as the wave 1 ETBs to complete data mapping and data migration in preparation for UAT commencing in January 2019.
- CoreHR Training: for the ESBS Team and ETBs in wave 1 has been ongoing through November & December 2018.
- Memorandum of Understanding (MOU): the text of an MOU between ESBS & each ETB was signed off by the Steering Group on 3<sup>rd</sup> December and an individual MOU will now be signed by the ESBS and each ETB.

### 2018 Highlights Contd.

 ESBS ETB Payroll Operations Recruitment: A successful EOI campaign was conducted in both the ETB sector and DES during 2018 and a number of staff have now joined the Operations team. The next phase of recruitment involves an EOI campaign to the wider Civil and Public Service which is ongoing.



### 2019 Key Focus Areas (Q1 & Q2)

- ETBI Townhall Event: the 2<sup>nd</sup> Payroll and Finance Shared Services Townhall event will take place on the 1st of February 2019 in ETBI Naas.
- ETB Engagement: Ongoing engagement will continue with ETBs in wave 1 and site visits to the next two ETBs; Laois | Offaly & Louth | Meath, will be scheduled in January 2019.
- ETB Training: The ESBS training team will deliver training to all ETBs in advance of go live with this training commencing in February 2019 for the Nominated Trainers from DDLETB and CMETB.
- User Acceptance Testing in advance of wave 1 go live will consist of two phases; Phase 1 begins on the 7th January 2019 and runs for 6 weeks with phase 2 commencing in March 2019.
- Parallel Running: planned for April & May 2019 for ETBs in wave 1.
- Go-Live: May 2019 for DDLETB and CMETB.

### Updates from ESBS Finance for ETBs Project



### Request for Tender (RFT) for a Financial Management System for ETBs has now been published on 21 December 2018

- Following Peer Review Group recommendation at end November 2018, formal approval from Digital Government Oversight Unit of OGCIO was received in December 2018.
- The RFT was published on 21 December 2018. The Project team worked with OGP and CSSO on final proof reading of RFT documentation which was completed to allow for publication. Following this publication, the expected RFT timetable is:

### Stage 1 - Pre-Qualification Questionnaire (PQQ):

- Candidates information session (mid Jan. 2019)
- PQQ clarifications closing date (end Jan. 2019)
- PQQ closing date (early Feb. 2019)
- PQQ evaluation to shortlist 3 to 5 bidders for Stage 2 (mid to late Feb. 2019)

#### Stage 2 - RFT:

- Tenders due from March 2019 (date to be set after Stage 1)
- Tender evaluation to select preferred bidder

- Project Design Authority meeting held on 21 November 2018
- Project Steering Group meeting held on 6 December 2018
- Report on EU co-financed e-Invoicing project which closed on 31 October 2018 to be submitted by year end
