3. Background

The Instructional Leadership Programme (ILP)

The ILP is a Professional Learning Programme for teachers, across all post-primary sectors which aims to nurture excellence in teaching and learning.

The Programme, which commenced in 2008, is offered through the Education and Training Boards Ireland (ETBI).

Specifically, the programme aims to:

- Encourage teachers to consciously modify their instructional actions to maximise student learning.
- Facilitate the conscious and deliberate utilisation of teacher actions skills, tactics & strategies.
- Foster an awareness of how a teacher's actions can impact on student learning motivation, novelty, authenticity, accountability, and safety.
- Re/Acquaint teachers with the extent to which learning is affected by; diverse learning styles, multiple intelligences, 'at risk environment' etc.
- Enhance classroom management and support the development of effective student teacher relationships.
- Encourage & Support Individual and Collaborative Professional Reflection

The programme focuses on pedagogy and systemic change. Participants attend in teams of three. It is compulsory that the principal or deputy principal is one of those members. The other two members were at the discretion of the school leader.

Over, 1700 participants have accessed the programme from across 295 post-primary schools, Further Education Colleges (FE) and Youthreach centres having participated in the programme.

The programme is residential based and delivered over four sessions within a two-year period. Each session is a 3-day workshop.

Participants are awarded a 'Certificate of Completion' on their graduation of the programme.

- 4. What school-level factors support or hinder the implementation of the learning from the ILP?
- 5. To what extent and in what ways does ILP impact student engagement?
- 6. To what extent and in what ways does ILP impact student achievement?

7. Reporting Mechanism

Quality assurance: The process the consultant will implement to ensure reliability of planning, design, documentation, and effective co-ordination of the physical aspects of the project.

Fee inclusions: Scope of services included in the fee proposal and the appropriateness of the quoted amount.
